Fri. Feb. 11th at 2 p.m. Jim Roemer & Mary Mayrs VS Keith Craven & Roseanne Mastrangioli.

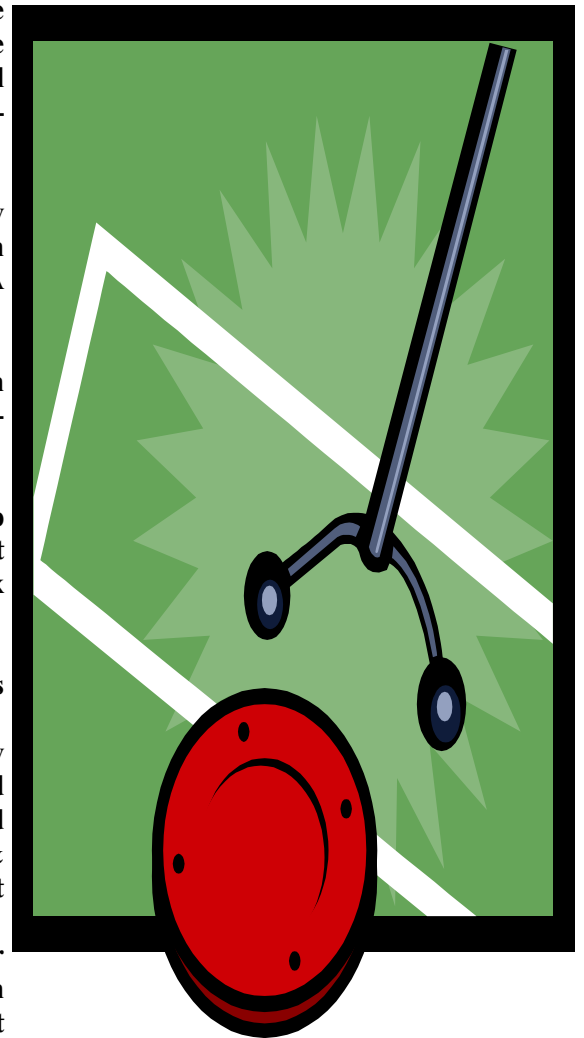
