That’s all folks.

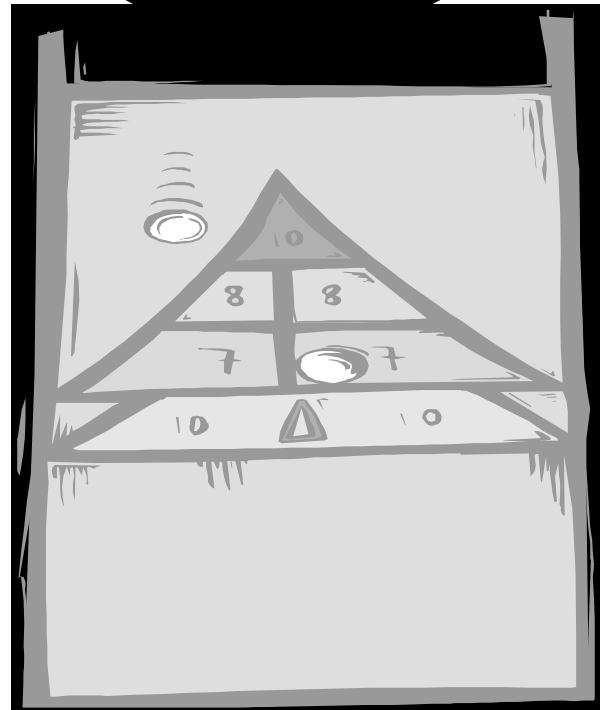
